Currently there is a surplus of \$12,932 in governance, a surplus of \$71,541 in Mission and Ministry, and a loss of \$5,977 in restricted and designated funds.

\$7,000 of the amount under professional/consultant fees was paid to Pinchin Ltd. for the assessment of Third Avenue United Church. We will recover the fees.

Heather reviewed the funds balances of Living Skies Regional Council. Some funds need to be reviewed.

A lot of people are leaving and retiring which is creating a large gap and increasing strain on remaining pastoral charge supervisors. This is a real issue since this is an important role to help people stay connected and there is a large area of the province where there are no called or appointed ministers.

## Universal Fund for Community Ministries

A proposal to establish an outreach ministries fund was originally brought forward at the 2021 Regional Meeting. Since the proposal was presented near the end of the meeting, there was not enough time to have a fulsome discussion as a gathered community. The proposal was passed to the Living Skies Regional Council Executive.

Rather than go through a separate process, it was agreed that communities of faith can donate directly to a universal fund, and that the monies donated to the universal fund will be combined with the Mission Support Grants budget. The Grants Committee will distribute the grants based on need exhibited by the various ministries through the grant application process.

#### 063 - 2020/2021

That Living Skies Regional Council Executive establish a Community Ministries Fund which would distribute voluntary donations from individuals and communities of faith, equitably across the various Regional Council ministries. 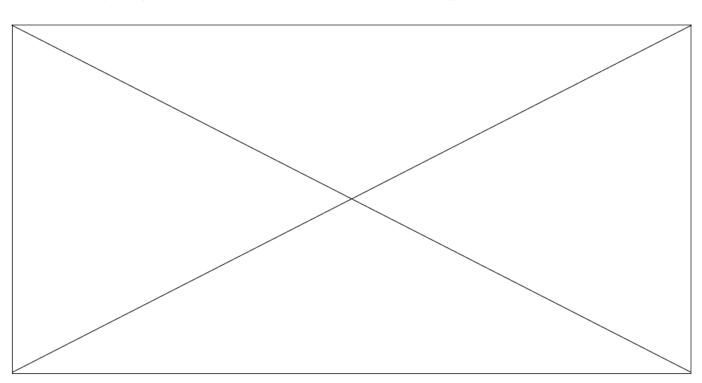

#### SASKATCHEWAN CONFERENCE INVESTMENT POLICY

#### **Preamble**

At present, Saskatchewan Conference of The United Church of Canada maintains cash and investments held at their banking institution, the Conexus Credit Union ("Conexus") and at the Fiera Capital Corporation ("Fiera").

The investments at Conexus are primarily Guaranteed Investment Certificates (GIC's) with "laddered" maturity dates so that as these GIC's mature they can either be liquidated or reinvested depending on cash requirements at the time.

The relationship with Fiera is as a result of an arrangement negotiated between The United Church of Canada Foundation and Fiera whereby United Church organizations can utilize this investment manager and a broad range of mutual funds.

Prior to the approval of an Investment Policy ("the Policy"), whether the monies are held by Conexus or Fiera, decisions for liquidation or renewal or the investment of surplus money are discussed between Saskatchewan Conference staff to the Finance and Administration Committee ("staff") and the convenor of the Finance and Administration Committee and then submitted to submitted to the Finance and Administration Committee for approval or ratification.

# Objectives:

It is intended that the Policy will achieve two objectives:

- Increase revenue from investments by restructuring the total investment portfolio and by utilizing Fiera as the primary portfolio manager, and
- Provide the staff with the authority and parameters so that they can manage the investments in a prompt and efficient manner thereby avoiding the present need and delay.

#### Parameters:

- Fiera is to be the primary investment manager
- Any of the wide range of mutual funds that are managed by Fiera may be used in order to conform with the proportion of investments as appears in the Policy
- Investments must meet the Social and Environmental Screening Criteria approved by The United Church of Canada Foundation
- The proportion of investments as between equities and interest bearing debt shall be as follows:

Type of Invest Investment	Percentage of Total Investment
Equities	65 to 75%
Debt (Interest Bearing)	35 to 25%

Provided however that it is acknowledged that the investment portfolio which exists at the time of the approval of the Policy will not comply with the Policy until such time as all of the existing investments with Conexus have matured and the proceeds are transferred to Fiera.

#### Staff Responsibilities:

- To monitor monetary needs and surpluses considering the current balance of the account(s) at Conexus and anticipated expenditures and to transfer monies to short term investments with Conexus as may be prudent
- As existing investments with Conexus mature, the proceeds are to be transferred to Fiera.
- Surplus funds as become available are to be transferred to Fiera.
- The total portfolio is to be monitored monthly based upon information that is available from Fiera on the internet to ensure compliance with this policy.
- Perform a full review of the portfolio at least quarterly based upon information received from Fiera by mail which shall assess portfolio performance and conformity with this policy and shall be submitted to the Finance and Administration Committee Executive at its meetings.
- Withdrawals from the portfolio will happen as a result of the need for funds arising within the Conference Budget.
- Unplanned withdrawals, to meet emergent purpose(s) not anticipated within the Conference Budget require Finance and Administration Committee or Executive Committee approval.

Amendments to this policy may only be made by the Finance and Administration Committee or its Executive, by the Conference Executive, or at a general meeting of Saskatchewan Conference.

# Proposal to Living Skies Regional Council for Mission Supported Ministries

### **Background**

EDGE met with several community ministries of Living Skies Regional Council on April 22, 2021 to discuss strategic planning and coaching opportunities.

#### Strengths (Things to Celebrate)

- There was a terrific turnout of several community ministries, some who have already worked with EDGE and attended EDGE's Sustainability Cohort
- There is support from the Living Skies Regional Council to engage in a group process with EDGE for planning strategically together, strengthening the network of community ministries in Living Skies
- Living Skies community ministries have a long-standing presence and ministry of building relationships

#### **Primary Challenge**

Creating a community ministries strategic plan for Living Skies Region. This will increase leadership capacity through building partnerships within the existing ministries, but also with partners outside The United Church of Canada.

#### Secondary Challenge

Some community ministries desire additional support and partnership as they face specific challenges within their context.

#### **Proposal**

EDGE would like to engage with Living Skies Regional Council through a resourced coaching process. In meeting with some of the community ministry leadership, it is evident that there are energy and ideas. There is also a sense that clarity and focus would help with resilience as the various ministries consider their future. Strategic planning can help identify strengths already present in the communities, and explore how to build on those strengths to help face the future.

EDGE coaching includes access to an online tool kit of resources, regular coaching for the leadership teams in developing the capacity for and practices of adaptive learning. EDGE will help the community ministries integrate new learning into their particular contexts.

Living Skies Community Ministries are on unique journeys where the ways forward will not always be clear and where new skills and capacities may be needed. EDGE's coaching process will support the leadership teams as they navigate their way through.

EDGE is proposing three ministry cohorts to engage in Strategic Planning- namely Camps, Chaplains, and Restorative Justice. These cohorts will engage in a broader strategic planning process together to come away with a broader understanding of their ministry area, and develop specific plans for their organizations.

Success would be leadership teams that...

- 1. Had a clear strategic plan and vision of next steps
- 2. Felt it had increased capacity to pursue possibilities through new partnerships, including partnerships with local business coaches for ongoing support
- 3. Is able to inspire and welcome new leadership, participants, and partners in its ministry

#### <u>Timeline</u>

Each cohort will complete a strategic plan through either:

- 1 coaching session per month for 6 months, or
- 2 coaching sessions per month for 3 months for those cohorts feeling more urgency

Start time: Spring 2021

Meetings 1-3 – Develop a Strategic Plan (including SWOT, long-term planning, and partnership development)

Meetings 4-6 – Exploring and Identifying the skills and resources that are needed to sustain the strategic plan

#### **Pricing**

3 Community Ministry Cohorts at \$2,070 per cohort (each cohort includes 6 coaching sessions)	\$6,210
Consulting Rate for additional consulting and work	\$115/hr
For example: - Partnership Initiation Conversation might be an hour or two long - Community Round Table typically takes 8 hours (\$920)

# PROPOSAL – The Micah Mission

# **Background**

#### Strengths (Things to Celebrate)

- Volunteer based restorative justice organization working with people who are or have been involved in the justice system.
- Successful, established programs: Person to Person; Circles of Support and Accountability; Community chaplaincy; Indigenous Program (needs some reworking).

#### **Primary Challenge**

 Developing a Strategic Plan that focuses on making The Micah Mission sustainable, keeping important program offerings running.

#### **Secondary Challenges**

- Funding for Circles of Support and Accountability (CoSA) and the Indigenous programming end March 2022.
- Potential partnerships with Parkland Restorative Justice, CoSA in Prince Albert, and CoSA South Saskatchewan in Regina.

# **Proposal**

EDGE would accompany The Micah Mission through a resourced coaching process. We would develop a strategic plan, including a vision, a strategy for developing partnerships, and ways of exploring new opportunities. EDGE will support the leadership team as they identify and navigate their way through their context.

#### Success would be a leadership team that...

- Has a strategic plan to address funding concerns;
- Has developed confidence and courage through understanding what options might be available to The Micah Mission; and
- Has increased ability to develop partnerships in moving forward.

We propose this work can take the shape of one of the three options listed below:

#### Option 1

June-July 2021 - 6 x 90-minute coaching sessions with the leadership team

#### Option 2

June 1-25,  $2021-2 \times 90$ -minute coaching sessions with the leadership team Saturday, June 26 - 3 hour Strategic Planning Day July  $2021-2 \times 90$ -minute coaching sessions with the leadership team

#### Option 3

Saturday, June 26 - Full-Day Strategic Planning Day\*

Please consider the options with regard to time commitment of those involved. If a hybrid or another option would work even better for your team please let us know.

# **PROPOSAL**

# **Background**

#### Strengths (Things to Celebrate)

- Multiple community ministries are active in the region and invested in future of their organizations and their regional relationships
- There is some funding to research and experiment with models and strategic plans that will help with long-term sustainability and community impact

#### Primary Challenge

- Each community ministry is having to create their own infrastructure, including governance structures, grant writing, sourcing funding, communications, and partnerships

#### Secondary Challenges

- Improving relationship with region, creating partnership and mutual support
- Several organizations are struggling to remain sustainable with shifting funding availability
- All organizations have been impacted by the realities of the pandemic in 2020 to the present
- A sense of displacement following The United Church of Canada's governance reorganization that often left community ministries feeling isolated and unsupported

#### <u>Proposal</u>

EDGE would like to explore the possibility of creating a centralized infrastructure system for the community ministries that would enable several organizations to partner when applying for funding, making governance decisions, and developing additional partnerships. We could pilot a model that could potentially be shared with other regional councils on best practices around supporting and encouraging community ministries to thrive.

We propose to hire a partner coordinator that performs this work with EDGE accompanying them in writing joint grants, marketing, and partnership development.

#### Success would be a leadership team that...

- 1. A Pilot that we can learn how best to centralize infrastructure to support multiple community ministries within one region
- Build confidence and the technical skills to write grants, build partnerships, community economic development, ability to rollout shared platforms and facilitate collaboration amongst organizations.
- 3. Have a return on investment of this position that benefits the entire region

# <u>Timeline</u>

6-month support to recruit and orient the Partner Coordinator

#### Meeting Frequency:

- Monthly online meeting with the leadership team
- Weekly check-ins with the Partner Coordinator (this is something that the larger team could be part of)

#### **Pricing**

EDGE Partner Coordinator Support	\$ 5,000
