Mineral Royalties Offer	Living Skies Regional Council Property Commission decided that the offer is low, we are not prepared to accept it at this time. Shannon will advise Ross Walker.
Adjustment for allocation on multipoint charges	General Council do not adjust the new allocations for multi-point pastoral charges when one congregation closes. This seems to be discriminatory to small congregations which are usually part of a multi-point charges; when a single congregation closes there is no allocation in the future years. Adjusting the allocation would be simple as it could be based on each congregation's per centage share of the operating cost of the pastoral charge. Annette will write a letter to General Council executive with a copy to Living Skies Regional Council Executive raising our concern.
Liability Insurance on Abandoned Properties	George has sent Erik Mathiesen our list of abandoned properties with buildings regarding obtaining liability insurance, Erik has not replied.
RM of Maple Creek	Annette has contacted the owners of the adjacent property; they believe that they own this property. Annette will send them a letter and a copy of the title and an offer to sell this property to them for \$300.
RM of Piapot	Annette contacted the previous owner of the adjacent property. She advises there was a Presbyterian church and cemetery on this property; then the land was cultivated. This land has now been sold. It is now in pasture. Genealogical society shows 6 graves from 1916 to 1918. The previous owner is willing to put a plaque on the edge of the property identifying it as a former cemetery, the Commission concurs with the placement of this plaque. Annette will contact the new owner regarding the property.
