## POLICIES – REGIONAL MEETINGS

### **Refund of Meal Fees**

Those delegates to the Regional Meetings of Living Skies Regional Council who have registered prior to the deadline and paid the meal fee will be eligible for a refund of their meal fee, following the Regional Meeting, as a result of non-attendance at the meeting, provided that:

- They have advised the Regional Council Office by the catering deadline of their anticipated non-attendance and have requested a refund of their meal fee,
- Their reason for not attending relates to circumstances necessitating their presence elsewhere which could not reasonably have been anticipated prior to registering for the meeting (such as recent illness, medical procedures, disability or bereavement; ministry persons taking part in funeral services; becoming aware of family members or close friends who have been affected by sickness or accident; being advised of events requiring their attendance within a week or two of the meeting, etc.)
- Numbers of participants on which catering charges are based will not be adversely affected in a significant way by the refund of meal fees, and that
- The meal fee has not reassigned to an alternate delegate.

After considering the above, and due consultation, the Registrar may recommend the refund of the meal fee on compassionate grounds.

### **Late Fees**

In the information made available to appointed delegates, ministry personnel and registered visitors, the deadline date for registering for the Regional Meeting is indicated, along with the amount of the late fee in the case of registrations received after that date.

It is proposed that the late fee as outlined above be applied unless:

- Persons registering late have been named as alternates
- Late registrants can provide a reason or reasons for not registering prior to the deadline that is satisfactory to the Registrar
- It can be established that Youth delegates were not in a position to register prior to the deadline due to circumstances beyond their control.

### **GUEST SPEAKERS**

### Chief Cadmus Delorme Cowessess First Nation



Chief Cadmus Delorme, a Cree and Saulteaux, was the Chief of the Cowessess First Nation. Chief Delorme graduated from Cowessess Community Education Centre in 2000. He later moved to Regina to pursue a Bachelor of Business Administration and a Certificate in Hospitality, Tourism and Gaming Entertainment Management from the First Nations University of Canada (FNUniv), and a Masters of Public Administration from the Johnson Shoyama Graduate School of Public Policy. Recently, he has completed an Institute of Corporate Directors designation.

In 2012, Chief Delorme received the Queen Elizabeth II Diamond Jubilee Medal for his hospitality in walking with King Charles III and Queen Consort Camilla when they visited First Nations University of Canada in 2012 and in 2022, Chief Delorme received the Queen Elizabeth II Platium Jubilee Medal. In 2015 he was named one of CBC Saskatchewan's Future 40, which celebrates the

province's new generation of leaders, builders and change-makers under the age of 40.

In 2016, Chief Delorme was elected Chief at the age of 34. In 2019, Chief Delorme was reelected to a second term in office. Under his leadership, Cowessess First Nation has focused on economic self-sustainability for its nation and people and has moved forward on renewable energy, agriculture, efficiency in land use initiatives that have created both current and future business opportunities. Also, under his leadership, Cowessess First Nation focused on political sovereignty and has moved forward on Child Welfare Reform, empowering full jurisdiction when it comes to child protection, prevention, and the wellbeing of the entire family.

In 2021, Chief Delorme faced one of the hardest moments as Chief when the Saulteaux and Cree First Nation made international headlines with the validation of potentially 751 unmarked graves near the former Marieval Indian Residential School. Shortly after, Cowessess made headlines again as the first First Nations to sign an agreement with Ottawa and the province that returns jurisdiction over children in care to the First Nation. Federal legislation overhauling Indigenous child welfare was passed in 2019 and came into force last year.

Chief Delorme lives with his wife Kimberly, brother-in-law, daughter and two sons on Cowessess First Nation.

### Liz Settee

I was born and raised in Prince Albert. I graduated from St Mary's High School in 1976. I moved away from Prince Albert for many years and received my B.A. from Simon Fraser University and entered into the Masters program. During this time, I decided I wanted to do something to give back to my home community. Having done all the course work for the Masters I did not write and defend my thesis. To this day I am grateful my journey took the path I am on.

I moved back to Prince Albert in 2007 to help look after my aging father (92 at the time) and had several jobs until September of 2010 when I started working at P.A. Outreach as a Cultural Mentor. I learned a great deal from Elder Stuart Amyotte and other Elders who spent time with the youth of Outreach and in the community of Prince Albert and surrounding area. Threw Creator and community I was blessed and wrapped in a Star Blanket as an Elder. I am an Elder for Saskatchewan Rivers Public School, Prince Albert Police Service and work with the Ministry of Social Services along with many other community groups.

It is truly an honour to be able to give back to the community that gave me so much growing up.

### **Spirit Strong Singers**

Spirit Strong Singers originated in 2018 from group of passionate people who loved drumming. We are a group of 2 Spirit and women drummers from Treaty Six Territory and Homelands of the Metis in Prince Albert, SK. Their membership extends across Saskatchewan with most of the drummers living in Prince Albert and area.

### Phyllis McTaggart:

- speak for ourselves in the spirit of truth and gentleness, avoiding unhelpful generalizations and racial stereotypes;
- not interrupt when others are speaking;
- be mindful of language that is not inclusive;
- affirm the deep wisdom of silence and pause, as necessary, to ponder what others have said:
- seek to understand rather than win arguments and assume best intentions;
- · hold our beliefs and opinions lightly; and
- · hold one another in prayer.

### **HOLY MANNERS**

The Very Reverend Marion Pardy introduced Holy Manners as a resource for the 38th General Council 2003. Holy Manners has been used as resource for the conduct of meetings by subsequent General Councils and their executives. It has been adapted here for use as a resource by all councils and church bodies.

#### We will

- keep God at the centre of everything we do;
- · each speak for ourselves;
- · speak for a purpose;
- · separate people from problems;
- allow for full and equitable participation;
- attend to others carefully without interruption;
- · welcome the conflict of ideas:
- take a future orientation;
- demonstrate appreciation;
- honour the decisions of the body;
- commit to holding one another to account when we do not keep our holy manners;
- · keep the discussion at the table;
- be mindful of our body language;
- check in about good use of time;
- allow the quiet people to speak, with an invitation to speak; and
- sincerely say what we really feel.

### **MEETING PROCEDURES**

(Numbering in this section is from the 2023 Manual Appendix pg. 191-195 and only includes sections relevant to this meeting)

### 3.1 The Chair

The chair keeps a meeting of the council on track and may make rulings on procedure and the conduct of the meeting.

All members must be able to participate fully and comfortably.

Every voting member makes decisions on the basis of their own understanding of scripture and of the ethos of the United Church, in the light of Christian experience, and under the guidance of the Holy Spirit at work in the meeting of the council.

Any member of the council may bring to the attention of the chair any concerns about how a motion is being dealt with.

When an agenda has been adopted that specifies the time for particular items, such time shall be strictly adhered to, unless the council decides otherwise by a 2/3 majority of those voting.

The chair does not participate in the discussion or vote except in the case of a tie. If the chair wants to express an opinion, then they move aside from the role and ask another member to chair until the matter is disposed of.

### 3.2 How to Conduct a Meeting

#### 3.2.1 Process

A council may set its own process for conducting business. If the council has not set its own process, it follows the parliamentary rules accepted in Canada (Bourinot's Rules).

### 3.2.2 Motions

A council may only pass motions for which it has the authority and which do not contradict the decision of a higher council.

A motion contradicting a motion already passed at the same meeting is out of order, unless it is a motion to reconsider.

### 3.2.3 Challenging Rulings

A voting member may challenge a ruling of the chair at the time the ruling is made. The chair restates the ruling and may give reasons. The secretary then calls the vote without any discussion on whether the chair's ruling is sustained.

### 3.3 How to Amend a Motion

When a motion has been made and is open for discussion, any motion to amend must be dealt with before dealing with the original motion.

When all motions to amend have been dealt with, the council may deal with the final form of the original motion.

Any voting member, except the mover and seconder of the original motion, may make a motion to amend the original motion.

A motion to amend fails if there is no seconder.

A motion to amend may not change the intention of the original motion.

A separate vote must be taken for each motion to amend.

### 3.5 Motions That Interrupt the Meeting

At any time during a meeting, any voting member may make a motion to

- a) close discussion without a vote on the motion;
- b) fix the time to adjourn;
- c) adjourn;
- d) take an immediate vote (2/3 vote required);
- e) limit or extend limits of discussion (2/3 vote required);
- f) postpone discussion and decision on the motion to a definite time;
- g) refer the motion to another body or commission;
- h) amend/change the motion; or
- i) postpone discussion and decision on the motion indefinitely (without a specified time).

An original motion may be interrupted by any of the above motions.

While these motions are being dealt with, they may only be interrupted by a motion above it in the list.

#### 3.6 How to Reconsider a Motion

A motion to reconsider a motion already passed may be made if no motion is under consideration. A motion to reconsider has the same priority as the motion to be reconsidered.

Only a voting member who voted "yes" for the original motion may move the motion to reconsider. This motion must be seconded by a voting member.

A motion to reconsider in an ongoing meeting must be approved by 2/3 of the voting members present.

The revised motion may be reconsidered if a motion is changed on reconsideration and passed.

A motion on which action has been taken may not be reconsidered.

### 3.7 Additional Procedures

In any point not covered in The Manual, the parliamentary rules accepted in Canada (Bourinot's Rules) will be followed.

### OTHER:

Divide a Motion (seriatim) This is a request to vote on a motion in parts rather than in total. A

seconder is required. If two persons ask, the chairperson must

grant the request.

Point of Information Any person can go to a microphone, interrupt debate and ask for

information. For example, "What page is this on?" or "Who is

speaking?".

Point of Order Any person can interrupt to challenge or question procedures. For

example, "We didn't vote", or "President, we are debating this

motion to table and we shouldn't be."

Point of Privilege Any person can interrupt debate to raise point of privilege. For

example, "Our table group doesn't have copies of this motion" or

"Could you please repeat the motion, I didn't hear it."

### Business Process at Living Skies Regional Council - May 25 - 27, 2023

The Living Skies Regional Council Commission has given approval in principle to using the General Council model for business at the inaugural meeting in Swift Current, 2019.

- Pre-Living Skies RC conversations: Topics of conversation of interest to the regional council will be solicited from the regional council to go to the Living Skies Regional Meeting. These conversations may help to inform proposals to the Regional Council or identify conversations the church wishes to hold.
- **New proposal format:** The template for proposals is designed to encourage naming an issue without specifying the outcome. "Conversation proposals" requesting a conversation on a particular issue are also encouraged.
- Priority agenda set by Living Skies Meeting Planning Team: Proposals will be reviewed and grouped by theme/issue. Proposals will be prioritized with the time available or referred to Living Skies Regional Council Executive.

- Three-phase decision-making: Regional Council Representatives will engage in a three-phase process for all Living Skies Regional Council business:
  - **1. Listening:** presentation of the proposal, questions and answers to clarify issues and implications.
  - 2. Discussion: exchange of ideas, thoughts, arguments and pros and cons; suggestions for refining proposal, affirmations, naming principles/parameters. Groups might also prioritize items as "we'd like to decide this together" and/or "We could live with the Living Skies RC Executive making these decisions if we run out of time."
  - **3. Decision:** final debate and refinement of proposal in plenary; working toward consensus, voting

While a consent motion will be used for some items, the majority of business the Living Skies Regional Council discusses—the priority identified themes/issues—will follow the three-phase decision-making process:

- **1. Listening phase:** Information sessions inform Living Skies RC representatives about the issues on the agenda. Information sessions may be held in plenary or in table groups.
- **2. Discussion phase:** Representatives meet in table groups with a pre-named Facilitator and a note-taker.

Discussion groups share what they have heard through the Listening phase so everyone is informed about all the issues. Discussion groups deliberate on the proposals. Note-takers record comments, affirmations, and suggestions, and the groups confirm the information to be recorded and shared. The reports from all discussion groups are available for viewing by all representatives as well as by the facilitation group.

**3. Decision-making phase:** The Facilitation group's refined proposals are made available to Living Skies RC members.

There is final debate and refinement of the proposal in plenary, with the facilitation group returning to do more refinement as necessary. The process concludes with a motion in response to the proposal and a vote on the motion.



### **BASIC RULES for DEBATE on PROPOSALS**

1. Prior to the Regional Council Meeting, proposals are received for information and consultation by the Regional Council Meeting Planning Committee. The Committee may make editorial suggestions to the proposing body to promote accurate understanding of the proposal by the people at the Regional Council Meeting. The Committee will communicate these suggestions to the proposing body and the proposing body may, or may not, take the suggestions.

Proposals that are received and edited prior to the Docket deadline will be included in the Docket. Proposals that have not been received and edited prior to the Docket deadline will be provided in written form at the Regional Council Meeting.

The proposals will be available in a variety of ways: typed hard copy, via PowerPoint, and read aloud at the time of decision-making.

2. The Flow Table will meet to decide in what order the proposals will be placed before the Council. This order will be presented to the Council during the first business session on the agenda.

### 2023 MEETING OF LIVING SKIES REGIONAL COUNCIL ENABLING MOTIONS

- 1. Roll of Regional Council: that the Roll of the Regional Council for the purposes of the meeting be:
  - i. the members of the Order of Ministry within the bounds served by the regional council; and
  - ii. Other ministry personnel in a covenantal relationship with a community of faith within the bounds of the regional council
  - iii. lay members of the regional council are members of the United Church who are not ministry personnel and who are elected by communities of faith. (Manual 2019, C.1.1 & C.1.2)
- **2.** Corresponding Members: that all invited guests, registered visitors, and staff be corresponding members of this regional council meeting, with voice but not vote.
- 3. The Bounds of the Council Meeting: that for voting purposes the bounds of the Council Meeting shall be the numbered tables on the floor, when in session and that the Living Skies Regional Council hold a Celebration of Ministry Service including ordination, commission and admission to the order of ministry of The United Church of Canada on May 28, 2023 at 10:00am at Calvary United Church, 114 25<sup>th</sup> St. E., Prince Albert to fulfill its responsibility to ordain, commission and admit those whom the Office of Vocation has confirmed as having completed all the requirements and whom the Regional Council has confirmed have a covenantal relationship in place with a community of faith.
- **4.** Minimum Number of Members at Meetings: that the regional council may meet only if a minimum number of members is present. If there are 60 or more members, at least 20 members must be present; and there must be at least one ministry personnel and one lay member who is not ministry personnel present. Corresponding members are not counted for this purpose. (Manual 2023; C.4.3)
- **Limits to Debate:** that without the permission of the Council, no member shall speak more than once on any proposal or amendment; and that speeches be limited to two minutes per person on each proposal, except at the discretion of the Chair.
- 6. <u>Election Procedures for Vacancies in Regional Council Appointed Positions</u>: that the Nominating Committee present a slate of names for all vacancies at a time prior to the meeting; and that all other nominations will be given to the chair of Nominations for consideration and presented to the Executive for approval.
- 7. <u>Scrutineers</u>: that the responsibilities of Scrutineers are to distribute, collect and count ballots, reporting the result to the Convenor or Executive Minister; and to count show-of-hand votes when requested by the Convenor or the Council.
- **8.** <u>Agenda Committee</u>: that the Agenda Committee for this meeting of the Regional Council be the members of the Regional Council Meeting Planning Committee, plus one person designated as Parliamentarian, George Thurlow.
- 9. <u>Materials to be Distributed</u>: that aside from documentation relevant to this meeting, no other material shall be distributed to Regional Council Attendees or placed on tables or put on PowerPoint, within the bounds of the Regional Council Meeting without permission of one of the Regional Council Meeting Planning Committee and Convener or a designate, or the Executive Minister.
- **10.** Rules of Debate and Order: that the rules of debate and order for Parliamentary debate be those spelled out in Appendix of The Manual 2023 (pages 191-195); and that any point not covered in such Appendix, the parliamentary rules accepted in Canada (Bourinot) shall be followed.

- 11. Reports: that the verbal and written reports be accepted as presented.
- **12.** <u>Minutes</u>: that the minutes of the 3rd Regional Gathering of the Living Skies Regional council be approved as distributed in the online docket.
- **13. Proposals:** that all unfinished business be referred to the Living Skies Regional Council Executive
