

# **Property Commission Quarterly Report**

to Living Skies Regional Council Executive January 1 to March 31, 2023

The LSRC Property Commission held two meetings in the first quarter of 2023 (January 13, February 24). This report outlines the status of our work as of the end of the quarter and also summarizes the decisions that were made in the past three months.

## **Congregational Properties:**

We are currently working with fourteen communities of faith. As of December 31, 2022 we have two communities of faith that are planning to renovate, rent or purchase property, eight in the process of selling property, and six that are in the process of disbanding. In the past three months the following decisions were made:

Approval of Sale/Transfer of Church Buildings and/or Lots:

- January 13, 2023 Centre Street United Church in Shaunavon (to Darkhorse Theatre Inc. for \$25,000, congregation will have use of building for Sunday worship)
- February 24, 2023– Penzance United Church (to Darren Lane for \$1000)

Disbanding of Congregation/Pastoral Charge:

January 13, 2023 – St. James United Church in Lashburn

## **Abandoned Properties**

We are continuing our work to sell or transfer abandoned properties within the LSRC Regional Council. Some are being transferred to the village or rural municipality and others are being sold to neighbouring landowners. These are the decisions made in the last three months:

- January 13, 2023 Mineral Royalties Offer Request The United Church of Canada to approve, sign and seal the lease agreement on the NW 28-10-05-2 Ext 0 Title number 107056234 with Land Solutions on behalf of their client with the following conditions: \$85.00 per acre, a 3-year Term and a 15% Royalty
- January 13, 2023 Pemoco Offer for Moats Land Surface Rights– \$225,000.00 for each quarter section of land for a total of \$450,000.00 which would be split between the Church and the College as ½ Interest Title Holders. Recommended to LSRC that that in solidarity with St. Andrew's College we refuse the offer from Pemoco to sell the surface rights at this time.

Request Approval from LSRC Trustees for Sale/Transfer of Church Property

- February 24, 2023 St. Andrew's United Church in Churchbridge (transfer of three lots to Cindy and Bruce Basken for \$1000) Note: this sale took place in 2010 but the title was never transferred
- February 24, 2023 Rillington United Church (2 lots to RM of Elcapo)

#### Cemeteries

Request Approval from LSRC Trustees for Sale/Transfer of Church Property

 February 24, 2023 – Old Stone Church and Cemetery (to RM of Abernethy)

#### **Policies & Processes**

The Property Commission is doing a final review of the sample lease agreement prepared by legal counsel. This agreement will be made available to all congregations to provide information for them to consider when they are leasing their facilities to outside groups.

We have also been working on checklists that congregations can use when selling property and/or disbanding.

Thanks to the members of the property commission, Bev Kostichuk, Daryl Woods, George Thurlow, Jonathan Zacharias and Shannon McCarthy for your continuing dedication to this important work.

## **Paid Pastoral Charge Supervisor Position**

#### 1. What is the issue?

The issue facing Living Skies Regional Council is the shortfall of volunteer Pastoral Charge Supervisors in comparison with the number of Pastoral Charge Supervisors needed within Living Skies Regional Council.

## 2. Why is this issue important?

The United Church Creed states: "We are called to be the church..." Christian faith understands the Church to be the Body of Christ, working together to live out the Good News of God's transforming love revealed in Jesus Christ.

The polity of the United Church of Canada has a Three Council system of governance which includes support and accountability as a means to live out the calling to be the Body of Christ.

One of the practical applications of this principle of being the Body of Christ, is to support communities of faith when there is no paid accountable minister authorized to exercise the ministry of supervision in that faith community.

This situation happens in a variety of circumstances:

- a) when there is no ministry personnel serving a community of faith.
- b) when the ministry person is a candidate for ministry, or in a supervised ministry educational setting, or an admittant from another denomination.
- c) whenever there is a change in pastoral relations, a supervisor is needed while the faith community begins the search for a new ministry person.
- d) when a ministry person is away for a period of time such as sabbatical, maternity leave or medical leave

In these situations, communities of faith are supported by Regional Council members appointed by the Living Skies Regional Council Pastoral Relations Commission to serve as Pastoral Charge Supervisors.

Current Context of the United Church in Living Skies Regional Council.

- --There has been great change including:
  - a) closing of many congregations which affect the financial viability of multi-point pastoral charges as well as the pool of volunteers to serve in the wider church.
  - b) reduction of many ministry positions from full time to part time therefore making it difficult to attract ministry personnel to those positions.
  - c) a lack of ministry personnel to fill all positions.
  - d) fewer volunteers as many faith communities become smaller and members are generally older.
  - e) since the establishment of the Regional Council there has never been a time when all requests for Pastoral Charge Supervisors have been met. The need is greater than the number of volunteers available to serve. There are often 5 to 8 Pastoral Charges waiting for an appointment of a Pastoral Charge Supervisor every month. Some are waiting 6 to 10 months for a person to be appointed.

## 3. How might the Regional Council respond to this issue?

The Living Skies Pastoral Relations Commission requests:

- a) Living Skies Regional Council establish a quarter time paid Pastoral Charge Supervisor position.
- b) Living Skies Regional Council Executive in consultation with the Living Skies Regional Council Pastoral Relations Commission establish the ministry position with appropriate budget.
- c) the appointment and accountability of the Pastoral Charge Supervisor continue to be the responsibility of the Living Skies Regional Council Pastoral Relations Commission.

### Suggestions for possible establishment of the positions:

- a) A full-time ministry position could be established, incorporating a part-time paid Pastoral Charge Supervisor position in conjunction with a part-time ministry position in a given community of faith.
- b) The paid Pastoral Charge Supervisor program be evaluated 3 years after implementation to see if the movement from unpaid volunteer work to work that has financial compensation has the desired result.
