REVIEW OF KNOX METROPOLITAN UNITED CHURCH	First Dawn Eastern Edge Regional Council provided us with the motions that they made in regards to this review:

That the Living Skies Regional Council Pastoral Relations Minister, or their delegate, work with Knox Metropolitan United Church to implement and monitor the following decisions:

That given that Rev. Fraser is leaving Knox-Metropolitan United Church, that Knox-Metropolitan United Church requests the services of an Interim Minister, or Intentional Interim Minister for 24 (twenty-four) months, or whatever time is deemed appropriate, while the church develops its proposal for a way forward, and that the J.4 review report, recommendations, and decisions be shared with the Interim Minister before final appointment.

That the Governing Body, and/or Interim Ministry Transition Team, whichever is deemed appropriate, enable the following things as soon as possible, (a) develop a proposal that incorporates its vision of Knox-Metropolitan United Church being more of a Community Hub as per suggestions from the McNair report and elsewhere. Confer with other Knox-Metropolitan United Church groups about the proposal. Take it to the congregation to see if this meets with approval. (b) whether or not the congregation is in favour of the above-noted proposal, revisit the Knox-Metropolitan United Church governance structure to see what is working and what is not working. If the congregation is in favour of pursuing the community hub plan and/or the idea of a general manager, alter the governance model accordingly.

(c) develop a Ministry Profile once the church knows the direction it is heading.

That, effective immediately, Elizabeth Stroeder have full access to the worship services and sacraments of Knox-Metropolitan United Church, and shall not be involved in any groups or committees related to governance or administration of the church, or any position that has direct bearing on any ministry personnel at the church, or any groups or activities in the church, for a period of no less than five years. If, after 5 years, that Elizabeth Stroeder wishes to return to full participation in the life and work of the church, that she be required first to take a program focused on maintaining a respectful workplace and that the program must be approved by the Living Skies Regional Council.

That the governing body amend Hart Godden's contract in two ways as soon as allowable:

Firstly, to ensure it conforms to Canada Revenue Agency rules and secondly, that the Event Coordinator & Supervisor of Caretakers role be severed from Hart Godden's duties and his remuneration be adjusted accordingly, and that should there be a conflict of interest, that the Music Director not be permitted to sit on any committee or group that handles Knox-Metropolitan United Church rentals. That the governing body immediately merge the Use of Church group and Administration Ministry, assess the terms of reference, elect members, and establish accountability to the governing body.

That KMUC takes steps to ensure that all rental arrangements are in line with CRA requirements.

To aid in the restoration of the health of the community of faith, that individuals participating in the life and work of Knox-Metropolitan United Church; the governing body, the M&P Committee, employees of KMUC, and others identified by the governing body be required to take a program focused on maintaining a respectful workplace. The program must be approved by the Living Skies Regional Council.

That a functioning, trained Ministry & Personnel Committee, as outlined in the United Church of Canada Ministry and Personnel Committees: Policy, Procedures, Practices handbook, be established and be accountable to the governing body. That Knox-Metropolitan United Church make this review report only physically available for its congregants at a designated time and place to view. The report shall not be distributed electronically, in paper format, or in any other way to congregants. Staff at The United Church of Canada, including the Regional Council, may view this report, in any format, if connected to the performance of their roles.

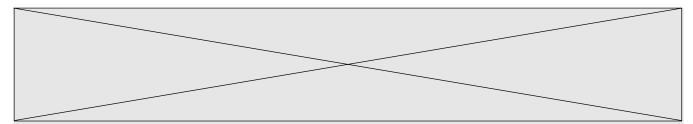

*<u>Note</u> to go with the recommendations for the Executive:
