## **1. Living Skies Regional Council News**

#### **NEW:** Remit voting is finished; next steps

- Voting on the autonomous Indigenous organization within the United Church closed March 31, and General Council has a ten-day window after that to allow receipt of any mailed-in ballots, which will be counted as long as they were post-marked by March 31. We anticipate results will be announced after April 10, via the national newsletter E-ssentials. The Region will also use its own channels to make sure everyone receives the communication.
- Thank you to all who voted, and to all who facilitated and participated in courageous and honest conversations and decisions on this significant question. Our work together continues. No matter what, we in the majority non-Indigenous church remain in relationship with Indigenous United Church members and their communities, as the body of Jesus. We carry the Apologies and commitments of our ancestors in faith, and commitments made by the whole country, to change that shared relationship from one shaped by domination and colonization to one of justice, sharing, mutual respect, and love. We will plan more conversations together.

#### NEW: Proposals to the Regional Council meeting, June 13-15 2024

Proposals to the Regional Council or to General Council are the main avenue for asking the church to adopt policy positions or take specific and relevant action. They use a template for consistency, and to ensure that all the needed information for representatives or commissioners is included.

#### Childcare at the Regional Meeting Survey

The Regional Gathering Planning Committee is polling potential delegates to see if childcare will be needed. #### ATTENTION: Pastoral Charges with Manses

We have been notified by Erik Mathiesen, Chief Financial Officer of The United Church of Canada, about a requirement for all Pastoral Charges with manses to submit a CRA form related to "Underused Housing Tax" by April 30, 2024. It is the responsibility of the UC General Council and Regional Councils to flag the risk related to not complying. There is an apparent duty to file - with a penalty for noncompliance. N: Getting Starred in Stewardship – Wednesday, April 10 at 3pm or 5:30pm CT / 2pm or 4:30 MT Come on your own, or come with a team and join United Church people from across the country to learn some stewardship first principles.
