Report to Living Skies Executive June 2025, Communications and Justice Minister

Wildfires

Thank you to our chair for [writing this letter](#) as yet again, communities in the North faced early and intense wildfires. This is our new normal. I would like to suggest we work on setting up a tri-Region committee to look at emergency responses, fundraising, trauma support, and discussions of climate change impacts.

Gaza: We had an excellent and heart wrenching event on Gaza and why aid is not getting in, hosted by the Living Skies Just Peace group, with 50 people in attendance, including people from Ontario. The speakers and moderator were just excellent, as were the questions. In the midst of this horror, we continue to work alongside people who are incredibly courageous, knowledgeable, and skilled. Affirming work

All three Regional Affirming Committees met together and said they want to continue that practice twice yearly, with some collaborative tri-Region education and pastoral events.

UCC Apology to Two Spirit and LGBTQIA people, August 8 at General Council

Affirming Committees in Prairie to Pine and Northern Spirit have discussed subsidizing limited in person participation from two groups at the Apology in Calgary:
Affirming Committee members and/ or Executive members;
Elders and leaders in the Affirming movement, especially those hurt by the church and who wish to attend.

Again, limited numbers are proposed. And many may not be able to attend or won't wish to. In a discussion with a Regional colleague in ON, **we wondered if a \$500 limit on individual subsidies would be workable. Northern Spirit and Prairie to Pine have not discussed subsidy amounts; this discussion began only two days ago.**

In addition, the committee will be inviting as many churches as possible to hold communal in-person participation in the online Apology worship, so pastoral support can be offered and the Apology heard and given as a community. While the Apology will be welcomed by many, and difficult for many.

Heather provided the following explanation about the audit

- It is a clean audit – no concerns were identified

- At the end of 2024 we had \$4,392,031 in assets, \$22,941 in accounts payable. \$3,339,745 of the assets are in restricted funds (Financial Position page 4)
- We experienced a surplus of \$748, 610, instead of the budgeted deficit of \$135,002. This is largely due to the money received from the sale of Wesley UC (\$450,000) and investment income. The unrealized gain on investments of \$186,205 is only realized if we sell those investments at the same value or more, that they were valued at as of Dec 31, 2024 . (statement of operations page 5)
- The last page of the audit shows the value of the various restricted funds at the end of 2024. The top two funds (ANCC and MVUC in trust for ICM) are funds we hold for other organizations ... this amounts to \$961,641 which are not our funds.
- We do not budget for income and expenses in the restricted funds, because those funds are only available for the designated usage. Historically I have not budget investment revenue, in 2025 I have included a minimal figure for misc revenue.
