Tracy presented the *Lay Representatives to the Regional Council: Responsibilities and Privileges* document. There are two questions that needed some clarification:

1. Is it the expectation that the representatives are expected to attend the meeting of the Regional Council?
2. Is it expected that they serve on governing boards?

After some discussion it was decided that yes, the intent is for those representatives to attend the regional meetings, however, it is not something that we can enforce. The bare minimum is the liaison piece, and attending the meetings is one way to do that. As for the second point, each community of faith sets their own board structure and so the regional council cannot mandate that reps sit on those boards.

#### **Don Elliot Trust**

Dale had a conversation with Don Kindoop, Treasurer, from Estevan United Church in the spring about LSRC taking over the admin of the trust. The terms of the trust are workable with minimal admin or maintenance. Dale's recommendation is for LSRC to proceed with the consolidation.
